OUTPATIENT SERVICES AND SUPPORT, INCLUDING INTERNAL MEDICINE, ORTHOPEDIC SURGERY, SAME DAY SURGERY, SUBSTANCE ABUSE TREATMENT PROGRAM, POST TRAUMATIC STRESS DISORDER (PTSD) PROGRAM, DOMESTIC VIOLENCE PROGRAM, MENTAL HEALTH SERVICES, WOMEN'S CLINICS, OPHTHALMOLOGY, PREVENTIVE MEDICINE, DENTAL, AND REHABILITATIVE MEDICINE PROGRAMS.
