ADMINISTER BLOCK GRANT SERVICES WHICH PAY PROVIDERS IN BEHALF OF ELIGIBLE CLIENTS. SERVICES INCLUDE IN-HOME CHORE SERVICES; ADULT DAY SERVICES; HOME DELIVERED AND CONGREGATE MEALS; TEACHING HOMEMAKERS; ADULT PROTECTIVE SERVICES; RESPITE CARE FOR ADULTS: TRANSPORTATION.

INCOME AND NEED ELIGIBILITY AND AT LEAST 19 YEARS OF AGE. THOSE RECEIVING SSI AND/OR STATE SUPPLEMENT CHECK ARE INCOME ELIGIBLE. OTHERWISE MAX GROSS MONTHLY INCOME IN YEAR 2002 IS \$924 FOR FAMILY SIZE OF ONE AND \$1036 FOR TWO. MUST ALSO HAVE A PHYSICAL OR MENTAL IMPAIRMENT TO CREATE A NEED FOR THE SERVICE.
