### ADULT FAMILY HOMES, DHHS, ADMIN

#### Description:

ADMINISTER THE PROGRAM. LOCAL DHHS OFFICES CAN CERTIFY AN ADULT FAMILY HOME. THIS IS A RESIDENTIAL LIVING UNIT WHICH PROVIDES FULL-TIME RESIDENCE WITH MINIMAL SUPERVISION AND GUIDANCE TO NOT MORE THAN THREE INDIVIDUALS AGE 18 OR OLDER. THIS INCLUDES BOARD AND ROOM WITH HOUSEHOLD FACILITIES TO ENSURE CLIENT COMFORT. THE INDIVIDUALS MUST BE ABLE TO SELF ADMINISTER MEDICATIONS, AND THEY MUST NOT REQUIRE ONGOING MEDICAL TREATMENT. FOR DHHS TO PAY THE FULL COST, THE INDIVIDUAL MUST BE ELIGIBLE FOR PUBLIC ASSISTANCE. IF AN INDIVIDUAL WANTS TO PAY PRIVATELY, A COST IS NEGOTIATED.

#### Eligibility:

18 YEARS OR OLDER AND CAN ADMINISTER OWN MEDS AND DO NOT REQUIRE ONGOING MEDICAL TREATMENT. MUST ALSO BE A NEED FOR SUPERVISION AND GUIDANCE.
