#### **Description:**

TREATMENT SERVICES FOR ADULT, CHEMICALLY DEPENDENT MALES (EXCEPT FOR THE SHORT-TERM RESIDENTIAL PROGRAM WHICH DOES ALLOW FEMALES). FIVE PROGRAMS: 1) TRANSITIONAL RESIDENTIAL HALFWAY HOUSE-MAINTAIN EMPLOYMENT, PARTICIPATE IN INDIVIDUAL AND GROUP COUNSELING AND DEVELOP SKILLS NEEDED TO DEAL WITH DAY-TO-DAY ISSUES. 2) SHORT TERM RESIDENTIAL-CALLED TOUCHSTONE (USES BOTH 12-STEP AND COGNITIVE ORIENTATION TREATMENTS). 3) INTENSIVE CARE MANAGEMENT-FOCUSES ON &apos;HIGH-UTILIZERS&apos; OF SERVICES WITHIN THE BEHAVIORAL HEALTH SYSTEM. 4) SOBER HOUSING-AFFORDABLE HOUSING FOR PERSONS COMPLETING THE HALFWAY HOUSE PROGRAM. ONLY MALE HALFWAY HOUSE IN 16 COUNTY RADIUS OF LINCOLN.

#### **Eligibility:**

SUCCESSFUL COMPLETION OF PRIMARY TREATMENT FOR CHEMICAL DEPENDENCY WITHIN THE LAST TWELVE MONTHS, A DESIRE FOR SOBRIETY AND A THREE MONTH RESIDENCY COMMITMENT, OR SUBSTANCE ABUSE EVALUATION THAT RECOMMENDS THIS LEVEL OF TREATMENT. TREATS ONLY INDIVIDUALS WHO HAVE BEEN REFERRED BY AN ESTABLISHED TREATMENT PROGRAM OR THOSE APPOINTED BY A LEGAL AUTHORITY. DO NOT ACCEPT DIRECT PLACEMENT AT REQUEST OF INDIVIDUALS, FAMILY OR FRIENDS.
