REHABILITATION DAY PROGRAM- COMPREHENSIVE OUTPATIENT PROGRAM THAT IS A COORDINATED, TRANSDISCIPLINARY APPROACH AND DESIGNED TO MEET EACH PATIENT'S INDIVIDUAL NEEDS, WITH A FOCUS ON GAINING REAL LIFE SKILLS THROUGH HANDS-ON COMMUNITY AND/OR WORK RE-ENTRY AND SCHOOL RE-ENTRY INTERVENTION. MADONNA'S SPORTS LENDING PROGRAM ALLOWS INDIVIDUALS TO CHECK OUT AND TRY A VARIETY OF ADAPTIVE EQUIPMENT TO USE ON A TEMPORARY BASIS BEFORE PURCHASING THEIR OWN. EQUIPMENT AVAILABLE INCLUDES: HANDCYCLE, SPORTS WHEELCHAIRS, GARDENING EQUIPMENT, FISHING RODS, HANDLE BOWLING BALLS, GOLF CLUBS. EQUIPMENT CAN BE CHECKED OUT FOR UP TO 10 DAYS. CALL 486.8274 AT LEAST 48 HOURS IN ADVANCE TO REQUEST EQUIPMENT.

ANYONE NEEDING ASSISTANCE. FOR MEDICAL TRANSPORTATION MUST BE PHYSICALLY DISABLED, FRAIL ELDERLY, AND/OR MEDICAID ELIGIBLE. ANYONE WHO NEEDS DR. APPT.
