HOMEBASED PRESCHOOL FOR CHILDREN WITH DISABILITIES AGED 0-2. SUCCESS 1.2.3 AND 4 FOR CHILDREN WITH DISABILITIES AGED 3-21. PROVIDES ALTERNATIVE CURRICULUM TO TEACH FUNCTIONAL LIVING SKILLS, COMMUNICATION AND SELF-HELP SKILLS. MOST SUCCESS PROGRAMS ARE IN GENEVA, EXCEPT 3 WHICH IS IN FAIRMONT. TYPE IN GENEVA, HENDERSON AND DORCHESTER, SERVE CHILDREN WITH LANGUAGE DISORDERS AGED 2 1/2-6. STAFFED BY SPEECH/LANGUAGE PATHOLOGIST AND SPECIAL EDUCATION TEACHERS. SEVEN SCHOOL DISTRICTS COMBINED FOR THIS PROGRAM. THEY WILL ACCEPT FROM OTHER DISTRICTS
