### **Description:**

MEDICAID PAYS FOR MEDICAL CARE FOR LOW-INCOME NEBRASKANS. TYPES OF MEDICAL SERVICES ARE HOSPITAL; NURSING HOME; PHYSICIANS; DENTAL; CLINIC; HOME HEALTH; FAMILY PLANNING; LAB AND RADIOLOGY; PRESCRIBED DRUGS; APPLIANCES AND HEALTH AIDS AND DEVICES. MEDICAID MAY ALSO COVER HOME AND COMMUNITY-BASED SERVICES FOR HIGH RISK INDIVIDUALS WHO ARE AGED, DISABLED OR THOSE WITH DEVELOPMENTAL DISABILITIES. ALCOHOL AND DRUG TREATMENT CAN BE PROVIDED FOR THOSE UNDER AGE 21.

### **Eligibility:**

ELIGIBILITY FOR MEDICAID IS DETERMINED THROUGH MANY DIFFERENT PROGRAMS BY THE PUBLIC ASSISTANCE CASEWORKERS IN THE LOCAL HEALTH AND HUMAN SERVICES OFFICES. QUESTIONS ABOUT MEDICAID SERVICES AND COVERAGE MAY BE DIRECTED TO THIS ADMINISTRATIVE OFFICE.
