### **SHARE A FARE**

#### **Description:**

SHARE A FARE IS A CAB SUBSIDY PROGRAM FOR THE LEGALLY BLIND, VISUALLY IMPAIRED AND LOW VISION RESIDENTS IN GREATER OMAHA. ENABLES THOSE HAVING BEEN CERTIFIED AS LEGALLY BLIND, VISUALLY IMPAIRED OR LOW VISION TO PURCHASE CAB COUPONS ON A MONTHLY BASIS AT A 50% DISCOUNT. CURRENTLY, A MAXIMUM OF \$75 VALUE CAN BE PURCHASED PER MONTH FOR A TOTAL OF \$37.50 (PLUS \$1.50 FOR SHIPPING AND HANDLING, IF REQUIRED, FOR A TOTAL OF \$39.00). UPON COMPLETING THE APPLICATION, SHOULD THE APPLICANT BE DECLARED ELIGIBLE, A LETTER ADVISING OF THEIR ELIGIBILITY AND PARTICIPATION INFORMATION WILL BE FORWARDED FOR THEIR FILES. SHARE A FARE IS A PROJECT OF THE AMERICAN COUNCIL OF THE BLIND OF NEBRASKA GREATER OMAHA CHAPTER.

CERTIFIED AS LEGALLY BLIND, VISUALLY IMPAIRED OR LOW VISION RESIDENTS IN GREATER OMAHA.
