GENETIC CONSULATIONS DEAL WITH ISSUES SURROUNDING THE OCCURRENCE OR RISK OF OCCURRENCE OF BIRTH DEFECTS OR AN INHERITED CONDITION IN THE FAMILY, QUESTIONS ABOUT DIAGNOSIS, CAUSE, PREVENTION, AND PROGNOSIS ARE ADDRESSEED. THE INTENT OF A CONSULTATION IS TO PROVIDE THE FAMILY AND PRIMARY PHYSICIAN WITH THE RESOURCES THEY NEED TO MAKE INFORMED CHOICES ABOUT MEDICAL MANAGEMENT AND FAMILY LIFE. WORK A LOT WITH SCHOOLS FOR BEHAVIOR PROBLEMS SUCH AS FETAL ALCOHOL GENETIC DISORDERS. TEAM COMES IN 4 TIMES A YEAR. CALL TO ARRANGE TIME FOR CONSULTATION. FEES: WILL BILL INSURANCE.
