## FAMILIES INSPIRING FAMILIES

### Description:

PROVIDES A FAMILY-RUN, FAMILY-FOCUSED, FAMILY ORGANIZATION THAT OFFERS EDUCATION, SUPPORT, RESOURCES, ADVOCACY, AND INFORMATION. PROGRAM TARGETS ADOLESCENTS WITH SERIOUS EMOTIONAL DISTURBANCES AND WHO ARE CURRENTLY EXHIBITING BEHAVIORS THAT MAY BE DETRIMENTAL TO THEMSELVES OR OTHERS. MOST OF THE YOUTH INVOLVED WITH THIS PROGRAM HAVE AN AXIS 1 CLINICAL DISORDER AND ARE AT RISK FOR OR ARE INVOLVED WITH THE JUVENILE JUSTICE SYSTEM. CARE COORDINATORS USE THE WRAP-AROUND APPROACH TO SERVE THE YOUTH AND THEIR FAMILIES. THE WRAP-AROUND TEAM WILL DEVELOP A PLAN AND GOALS BASED ON THE INDIVIDUAL NEEDS OF THE YOUTH. MAINLY SERVES YOUTH 12-18, BUT DOES WORK WITH YOUNGER OR OLDER IF HAVE MEDICAL DIAGNOSIS OR TRANSITIONING BETWEEN SERVICES. ANYONE CAN CALL SEEKING INFO ABOUT SERVICES AVAILABLE TO FAMILIES OF YOUTH WITH SERIOUS EMOTIONAL/BEHAVIORAL DISORDERS. ABLE TO PROVIDE: LIST OF COMMUNITY SERVICE PROVIDERS TO HELP WITH SPECIFIC NEEDS. BROCHURES FROM SERVICE PROVIDERS. ANSWERS TO QUESTIONS AND CONCERNS NOT ALWAYS ADDRESSED IN BROCHURES. TESTIMONIALS FROM OTHER FAMILIES REGARDING WHAT THEY FOUND TO BE HELPFUL. ADDITIONAL MATERIALS AND RESOURCE INFO. CONSULTATION WITH FAMILIES ABOUT QUALIFYING FOR F3 WRAPAROUND SERVICES.
