ALTERNATIVE FINANCING LOAN PROGRAM, NE.

Description:

PROVIDES LOW OR REDUCED INTEREST LOANS TO QUALIFIED NEBRASKANS WITH DISABILITIES FOR THE PURCHASE OF ASSISTIVE TECHNOLOGY DEVICES AND SERVICES. THESE DEVICES INCLUDE EQUIPMENT OR ITEMS TO HELP MAINTAIN, INCREASE AND IMPROVE THE INDEPENDENCE OR FUNCTIONAL CAPABILITIES OF INDIVIDUALS WITH DISABILITIES (EX: WHEELCHAIRS, MOTORIZED SCOOTERS, BRAILLE EQUIPMENT, SCANNERS, HEARING AIDS, AUGMENTATIVE COMMUNICATION SYSTEMS, ENVIRONMENTAL CONTROL UNITS, COMPUTERS AND ADAPTIVE COMPUTER PERIPHERALS, BUILDING MODIFICATIONS FOR ACCESSIBILITY, AND MOTOR VEHICLES REQUIRING MODIFICATIONS FOR ACCESSIBILITY (WHERE THE VALUE OF THE VEHICLE IS GREATER THAN THE COST OF THE MODIFICATIONS)). ASSISTIVE TECHNOLOGY SERVICES INCLUDE ADVISING THE CONSUMER IN THE SELECTION, ACQUISITION AND/OR USE OF ASSISTIVE TECHNOLOGY DEVICES. A SECOND PROGRAM, THE NE. TELEWORK LOAN PROGRAM, ALSO PROVIDES LOW OR REDUCED INTEREST LOANS TO QUALIFIED NEBRASKANS WITH DISABILITIES FOR THE PURCHASE OF ASSISTIVE TECHNOLOGY DEVICES AND SERVICES NECESSARY FOR SECURING TELEWORK EMPLOYMENT (EX: COMPUTERS. PRINTERS, SOFTWARE, FAX MACHINES, SCANNERS, OFFICE MACHINES, TELECOMMUNICATION DEVICES, TELECOMMUNICATION SYSTEM INSTALLATION CHARGES, OFFICE FURNITURE, HOME MODIFICATIONS FOR ACCESSIBLITY AND/OR TO CREATE HOME OFFICES, MOTOR VEHICLES, AND OTHER ASSISTIVE TECHNOLOGY). THIS WOULD INCLUDE PAID EMPLOYMENT REGULARLY PERFORMED AT A LOCATION OTHER THAN THE EMPLOYER & apos; S PLACE OF BUSINESS--SUCH AS THE WORKER'S HOME OR TELEWORK CENTER--AND/OR PAID SELF-EMPLOYMENT AT A PERMANENT LOCATION. PROGRAM SERVICES WILL GO BEYOND THE LOAN PROCESS TO INCLUDE CONSUMER COUNSELING, FUNDING COORDINATION, AND TECHNICAL ASSISTANCE WITH HELP FROM THE ASSISTIVE TECHNOLOGY PARTNERSHIP. LOANS FOR BOTH PROGRAMS RANGE FROM \$100 TO \$35,000. HAVE A LOW INTEREST RATE AND HAVE A MAXIMUM TERM OF TEN YEARS.
