PRISON MINISTRY RAINBOW SEEKERS CAMP-PROVIDES THE OPPORTUNITY FOR 80 INNER-CITY, FINANCIALLY CHALLENGED YOUTH TO ATTEND A WEEK-LONG SUMMER CAMP (SCHOLARSHIPS ARE AVAILABLE FOR 4TH-9TH GRADERS). RESPITE CARE SENIOR COMPANIONS-SERVE ONE-ON-ONE WITH THE FRAIL ELDERLY AND OTHER HOMEBOUND PERSONS WHO HAVE DIFFICULTLY COMPLETING EVERYDAY TASKS.
