### **HOME INSTEAD SENIOR CARE**

#### **Description:**

PROVIDES NON-MEDICAL ASSISTANCE TO INDIVIDUALS OR COUPLES CAPABLE OF MANAGING THEIR PHYSICAL NEEDS BUT WHO REQUIRE COMPANIONSHIP, LIGHT HOUSEKEEPING, MEAL PREPARATION, LAUNDRY, MEDICATION REMINDERS, SHOPPING, ERRANDS OR INCIDENTAL TRANSPORTATION IN ORDER TO REMAIN IN THEIR OWN HOMES. ALZHEIMER'S CARE. SERVICES ARE MOSTLY FOR SENIOR CITIZENS BUT NOT LIMITED TO THEM.

NEED ONGOING CARE OR ARE RECUPERATING. CAN CALL DIRECTLY OR MAY BE REFERRED BY ANOTHER AGENCY.
