VOLUNTEER SENIOR RESPITE AND COMPANION SERVICES. RESPITE VOLUNTEER SERVICES OFFER REST/RELIEF FOR FAMILY CAREGIVERS OF A DEPENDENT ELDERLY FAMILY MEMBERS OR DISABLED IN THEIR HOME. SERVICES INCLUDE LIGHT MEAL PREPARATION, CHEERFUL CONVERSATION, REMINISCING, OR ANY OTHER APPROPRIATE ACTIVITY. THEY ARE AVAILABLE 2-4 HOURS A WEEK. SENIOR COMPANION CARE OFFERS SOCIAL AND EMOTIONAL SUPPORT TO ELDERLY INDIVIDUALS LIVING ALONE, ENABLING THEM TO MAINTAIN THEIR INDEPENDENT LIVING AND SENSE OF WELL-BEING. INDIVIDUALIZE COMPANIONSHIP TIME TO MEET THE NEEDS AND INTERESTS OF THE ELDERLY CLIENT. THIS MIGHT INCLUDE ACCOMPANYING THE CLIENT SHOPPING, TAKING THEM OUT TO EAT OR TO A DOCTOR&apos;S APPOINTMENT, TAKING THEM TO VARIOUS COMMUNITY ACTIVITIES OR SERVING AS A LINK TO VARIOUS COMMUNITY PROGRAMS.
