Description:

THE PURPOSE OF THIS PROGRAM IS TO ENABLE PERSONS AGED 60 AND OVER TO REMAIN ACTIVE IN THEIR COMMUNITY THROUGH SUPPORTIVE PERSON-TO-PERSON SERVICE TO CHILDREN WITH SPECIAL OR EXCEPTIONAL NEEDS IN SCHOOL, HOSPITALS, DAYCARE OR HEADSTART. IF THE VOLUNTEER MEETS THE INCOME GUIDELINES, THEY WILL RECEIVE A NON-TAXABLE STIPEND, A DAILY MEAL, TRANSPORTATION ASSISTANCE, A YEARLY PHYSICAL AND EXCESS ACCIDENT AND LIABILITY INSURANCE.

INDIVIDUAL MUST MEET THE INCOME GUIDELINES TO QUALIFY FOR THE BENEFITS SITED ABOVE & MUST BE 60 OR OVER.
