#### **Description:**

PROGRAM IS VOLUNTARY AND FREE OF CHARGE. KEYA HOUSE IS A COMFORTABLE, CLEAN AND FURNISHED FOUR-BEDROOM HOUSE IN A QUIET AND SAFE NEIGHBORHOOD (AVAILABLE FOR UP TO 5 DAYS). PEERS HELP PEERS WITH CRISIS AVERSION AS WELL AS DIVERTING INDIVIDUALS FROM PSYCHIATRIC DISTRESS THAT MAY LEAD TO HOSPITALIZATION. PEER COMPANIONS STAFF THE HOUSE 24 HOURS A DAY. THEY ARE TRAINED, COMPASSIONATE, UNDERSTANDING AND EMPOWERING. SELF HELP AND PROACTIVE RECOVERY TOOLS AVAILABLE TO REGAIN AND MAINTAIN WELLNESS.

#### **Eligibility:**

ADULTS (19 AND UP) WITH A BEHAVIORAL HEALTH DIAGNOSIS AND WHO LIVE IN THE REGION V SYSTEMS SERVICE AREA. MUST HAVE TRANSPORTATION TO AND FROM THE HOUSE. CAN SELF-REFER OR BE REFERRED BY A HEALTH PROFESSIONAL OR A FAMILY MEMBER. MUST NOT BE IN CRISIS OR SEVERE EMOTIONAL DISTRESS.
