THE PREVENTION PROGRAM HELPS INDIVIDUALS MAINTAIN CURRENT HOUSING OR SEEK OTHER HOUSING OPTIONS TO PREVENT HOMELESSNESS.

ALSO A HOME OWNERSHIP PROGRAM THROUGH THIS AGENCY - 934.1777 TO PREPARE FIRST TIME HOMEOWNERS AND AID IN PREVENTING FORECLOSURES.
