ALSO PROVIDES A RESIDENTIAL ADDICTION RECOVERY PROGRAM-THE 'MIRACLES' TREATMENT CENTER. PROVIDES FACILITY SPACE FOR PERSONNEL FROM THE VISITING NURSE ASSOCIATION, CHARLES DREW HEALTH CENTER, CREIGHTON UNIVERSITY MEDICAL CENTER & MEDICAL SCHOOL, COMMUNITY ALLIANCE AND LEGAL AID OF NEBRASKA ALL OF WHOM PROVIDE MEDICAL AND MENTAL HEALTH CARE SERVICES AND LEGAL ASSISTANCE TO HOMELESS GUESTS.
