IMPROVE THE QUALITY OF LIFE BOTH PHYSICALLY AND EMOTIONALLY OF ADULTS AND CHILDREN WITH DISABILITIES THROUGH EQUINE ASSISTED ACTIVITIES. INCLUDES: THERAPEUTIC RIDING, HIPPO THERAPY (THIS DOES NOT TEACH HOW TO RIDE HORSE, BUT DONE BY A OCCUPATIONAL, PHYSICAL OR SPEECH THERAPIST TRAINED TO USE THE MOVEMENT OF THE HORSE TO FACILITATE IMPROVEMENTS IN INDIVIDUALS), THERAPEUTIC CARRIAGE DRIVING (INTERACTION AND CONTROL OF HORSE FROM A CARRIAGE SEAT), PUBLIC RIDING LESSONS, HORSES FOR HEROES (VETERANS OF ANY AGE AND DISABILITY ENCOURAGED TO PARTICIPATE TO PROVIDE OPPORTUNITIES FOR IMPROVEMENT PHYSICALLY, MENTALLY AND SOCIALLY), SUMMER CAMPS (FOR EITHER THE BEGINNER OR INTERMEDIATE RIDER), GROUP BARN TOURS, SPEAKERS, COLLEGE INTERNSHIPS AND SERVICE LEARNING HOURS AVAILABLE.
