### EXTENDED HOURS SERVICE TRANSPORTATION (LEAGUE OF HUMAN DIGNITY)

#### Description:

PROVIDES EVENING AND WEEKEND (SOME HOLIDAYS) AFFORDABLE, ACCESSIBLE PUBLIC TRANSPORTATION (NON-MEDICAL) IN LINCOLN CITY LIMITS FOR PEOPLE WITH DISABILITIES WHO NEED IT, WHEN OTHER OPTIONS ARE NOT AVAILABLE. SUCH AS GOING TO WORK, STORE, CHURCH, FAMILY OR COMMUNITY ACTIVITIES, SOCIALIZING WITH FRIENDS. MUST NOT HAVE A VALID DRIVERS LICENSE OR VEHICLE AVAILABLE TO THEM. MUST FILL OUT APPLICATION. IF ELIGIBLE FOR HANDIVAN MOST LIKELY ELIGIBLE FOR EXTENDED HOURS SERVICE. \$3.00/ONE WAY; \$6.00/ROUND TRIP. SERVICE PROVIDED BY TRANSPORT PLUS. PREFER 7 DAYS NOTICE.

#### Eligibility:

DISABILITY, NO VALID DRIVERS LICENSE OR VEHICLE. MUST FILL OUT APPLICATION @ LEAGUE OF HUMAN DIGNITY. IF ELIGIBLE FOR HANDIVAN MOST LIKELY ELIGIBLE FOR EXTENDED HOURS SERVICES.
