### ICAN CONNECT (DEAF-BLIND EQUIPMENT DISTRIBUTION)

#### Description:

CAN ASSIST INDIVIDUALS WHO EXPERIENCE A COMBINED VISION AND HEARING LOSS, OBTAIN EQUIPMENT TO BETTER ACCESS TELE/LONG DISTANCE COMMUNICATIONS. WILL FUND TRAINING AND INSTALLATION OF EQUIPMENT, UPGRADES, REPAIRS AND REPLACEMENT EQUIPMENT. EQUIPMENT DOES NOT NEED TO BE RELATED TO EMPLOYMENT, EDUCATION OR INDEPENDENT LIVING. EXAMPLES INCLUDE IPADS, IPODS, SCREEN READING SOFTWARE, BRAILLE DEVICES, LAPTOPS, TABLETS, ETC. CANNOT COVER HEARING, MAGNIFICATION, OR SIGNALING DEVICES THAT ARE NOT RELATED TO DISTANCE COMMUNICATIONS.

#### Eligibility:

MUST COMPLETE SERVICE AND DEVICE APPLICATION. IF ELIGIBLE WILL THEN COMPLETE ICAN CONNECT APPLICATION. THERE ARE INCOME LIMITS AND REQUIRED TO PROVIDE PROFESSIONAL VERIFICATION ATTESTING THE PERSON HAS A COMBINED VISION/HEARING LOSS THAT SIGNIFICANTLY IMPACTS HIS/HER ACTIVITIES OF DAILY LIVING.
