SUCH AS LIVING ARRANGEMENTS RELATED TO LONG TERM CARE, IN-HOME SERVICES SUCH AS HOUSEKEEPING, PERSONAL CARE, RESPITE, EQUIPMENT, CARE COORDINATION, PAYING FOR LONG TERM CARE SERVICES, HEALTH PROMOTION/PREVENTION, ADULT PROTECTIVE SERVICES, ABUSE, NEGLECT, FINANCIAL EXPLOITATION, MENTAL HEALTH SERVICES, FINANCIAL AND OTHER BASIC NEEDS SUCH AS FOOD, SHELTER, MEDICAID, MEDICARE, LEGAL ISSUES SUCH AS CONSUMER RIGHTS, ADVOCACY, POWER OF ATTORNEY, GUARDIANSHIP.
