### GAME AND PARKS COMMISSION-STATE

#### Description:

1) THE GAME AND PARKS COMMISSION IS RESPONSIBLE FOR PROVIDING OUTDOOR RECREATION, INCLUDING STATE PARK SYSTEM, HUNTING, FISHING AND BOATING. 2) PERSONS WITH DISABILITIES CAN APPLY FOR A SPECIAL PERMIT (APART FROM THEIR REGULAR PERMIT) TO HUNT AND FISH FOR SMALL GAME FROM A VEHICLE ON PRIVATE LAND. INDIVIDUALS UNABLE BY REASON OF PHYSICAL INFIRMITIES TO FISH IN A NORMAL MANNER MAY BE ISSUED A SPECIAL PERMIT. 3) ANY PERSON WHO IS 69 YEARS OF AGE OR OLDER AND A RESIDENT OF NEBRASKA IS ELIGIBLE FOR A \$5.00 ANNUAL HUNTING/FISHING COMBO PERMIT 4) VETERAN PERMITS- VETERANS OF ANY WAR WHO ARE A LEGAL RESIDENT OF THE STATE OF NEBRASKA AND 64 YEARS OF AGE OR OLDER ARE ELIGIBLE FOR AN ANNUAL \$5.00 HUNTING/FISHING COMBO PERMIT 5) PERSONS WITH DISABILITIES WHO WISH TO HUNT ARCHERY DEER, ANTELOPE OR TURKEY WITH A CROSSBOW, MUST ATTEST THE LOSS OF AN ARM THROUGH AMPUTATION OR LACK OF USE OF AN ARM THROUGH PERMANENT IMPAIRMENT WHICH RENDERS THE INDIVIDUAL INCAPABLE OF DRAWING A LONG BOW.

#### Eligibility:

1) ALL INDIVIDUALS ARE ELIGIBLE FOR VARIOUS ASPECTS OF OUR OUTDOOR RECREATION PROGRAMS. 2) LOSS OF THE USE OF AN ARM THROUGH AMPUTATION OR LACK OF USE OF AN ARM THROUGH PERMANENT IMPAIRMENT WHICH RENDERS THE INDIVIDUAL INCAPABLE OF DRAWING A LONG BOW. 3) SPECIAL PERMIT TO HUNT AND FISH SMALL GAME FROM VEHICLE ON PRIVATE LAND IF YOU CANNOT FISH IN A NORMAL MANNER.
