DENTAL HEALTH SERVICES

Description:

MAIN EMPHASIS IS DENTAL HEALTH EDUCATION AND TREATMENT OF CHILDREN LIVING IN LANCASTER COUNTY, INCLUDING THE CITY OF LINCOLN. THE PROGRAM IS INTENDED FOR CHILDREN AGES 3 THROUGH 18. AFTER CHILDREN RECEIVE TREATMENT, PARENTS OF THE CHILDREN BECOME ELIGIBLE FOR ROUTINE AND EMERGENCY DENTAL TREATMENT. ADULTS WITHOUT CHILDREN ARE ELIGIBLE FOR EMERGENCY DENTAL SUCH AS TOOTH PAIN OR A BROKEN TOOTH OR IF THEY HAVE A MEDICAL CONDITION SUCH AS HEART DISEASE OR DIABETES.

Eligibility:

INCOME GUIDELINES ARE USED TO DETERMINE ELIGIBILITY. SPECIAL CONSIDERATION IS GIVEN TO THOSE IN SITUATIONS WHERE UNUSUAL HARDSHIPS OCCUR. IT IS DESIGNED FOR THOSE WHO WOULD BE UNABLE TO RECEIVE DENTAL CARE BECAUSE OF LIMITED FAMILY INCOME. NOT FOR THOSE WITH PRIVATE INSURANCE, NOT FOR FOREIGN STUDENTS OR THOSE IN THE USA ON VISA DUE TO THE FACT THAT THEY DO NOT PAY LOCAL TAXES.
