PROVIDES NON-MEDICAL COMPANIONSHIP AND HOME CARE SERVICES TO INDIVIDUALS OR COUPLES CAPABLE OF MANAGING THEIR PHYSICAL NEEDS BUT WHO REQUIRE COMPANIONSHIP, LIGHT HOUSEKEEPING, MEAL PREPARATION, PERSONAL CARE SERVICES, LAUNDRY, MEDICATION REMINDERS, SHOPPING, ERRANDS OR INCIDENTAL TRANSPORTATION IN ORDER TO REMAIN IN THEIR OWN HOMES. ALZHEIMER'S CARE. SERVICES ARE MOSTLY FOR SENIOR CITIZENS BUT NOT LIMITED TO THEM.
