FRONTIER HOUSE-CLUBHOUSE RESIDENTIAL SUPPORT-DEVELOPED TO ASSIST PERSONS WITH SEVERE AND PERSISTENT MENTAL ILLNESS, THIS SERVICE HELPS CLIENTS LIVE IN A RESIDENCE OF THEIR CHOICE.
