THE BRIDGE BEHAVIORAL HEALTH

Description:

SUBSTANCE ABUSE TREATMENT CENTER SUPPORTED BY 24-HR. NURSING COVERAGE AND PHYSICIAN SUPPORT 365 DAYS A YEAR. SERVICES INCLUDE: 1) CIVIL PROTECTIVE CUSTODY (INVOLUNTARY DETOXIFICATION)-ADMITTED BY LAW ENFORCEMENT. 2) VOLUNTARY SOCIAL DETOXIFICATION-CLIENTS CAN STAY UP TO 5 DAYS. 3) SHORT TERM RESIDENTIAL (MEN ONLY)-INTENSE EDUCATIONAL AND TREATMENT PROGRAM. 15-30 DAY STAY. 4) SHORT TERM RESPITE-2 TO 7 DAY STAY FOR INDIVIDUALS WHO ARE EXPERIENCING CRISIS, BUT ARE NOT THREATENING SELF OR OTHERS AND MEDICALLY STABLE. MUST BE REFERRED BY AN AGENCY THAT WILL CONTINUE TO WORK WITH THE INDIVIDUAL. 4) INTERMEDIATE RESIDENTIAL CARE (IRC-MEN AND WOMEN)-CHRONIC SUBSTANCE ABUSER. LONG TERM STAY (UP TO 2 YRS). 5) CASE MANAGEMENT 6) SUBSTANCE ABUSE EVALUATIONS 7) DRUG SCREENING DRUG & ALCOHOL INPATIENT COUNSELING AND FAMILY COUNSELING, AA MEETINGS.
