Description:

STATEWIDE CLOSED CIRCUIT RADIO READING SERVICE FOR PEOPLE WHO HAVE DISABILITIES WHICH PREVENT THEM FROM READING PRINTED MATERIAL. SPECIAL RADIO RECEIVERS ARE REQUIRED TO HEAR THE BROADCASTS. THE RECEIVERS ARE LOANED TO ELIGIBLE CLIENTS. NEBRASKA AND IOWA NEWSPAPERS AND DOZENS OF MAGAZINES ARE READ ON A DAILY BASIS.

Eligibility:

MUST FILL OUT APPLICATION. BLIND PERSONS WHOSE VISUAL ACUITY, AS DETERMINED BY COMPETENT AUTHORITY IS. 20/200 OR LESS I THE BETTER EYE WITH CORRECTING LENSES, OR WHOSE WIDEST DIAMETER OF VISUAL FIELD SUBTENDS AN ANGULAR DISTANCE NO GREATER THAN 20 DEGREES. PERSONS WHOSE VISUAL DISABILITY WITH CORRECTION AND REGARDLESS OF OPTICAL MEASUREMENT IS CERTIFIED BY COMPETENT AUTHORITY AS PREVENTING THE READING OF STANDARD PRINTED MATERIAL. PERSONS CERTIFIED BY COMPETENT AUTHORITY AS UNABLE TO READ. SEE OR HANDLE STANDARD PRINTED MATERIAL AS A RESULT OF A PHYSICAL LIMITATION.
