EMERGENCY RESPONSE SYSTEM. CALLS COME INTO MASSACHUSETTS AND IMMEDIATELY WITHIN TWO MINUTES DESIGNATED CONTACTS CHOSEN BY PERSON ARE NOTIFIED INSTALLATION FEES RUN ABOUT \$50-\$100. MONTHLY FEES RUN ABOUT \$35-\$45.

##### **Eligibility:**

EVERYONE IS ELIGIBLE BUT ONE CAN BECOME ELIGIBLE BY QUALIFYING FOR ONE OF THE FIVE FOLLOWING PROGRAMS: 1. MEDICAID 2. FOOD STAMPS 3. SUPPLEMENTARY SECURITY INCOME (SSI) 4. FEDERAL PUBLIC HOUSING ASSISTANCE 5. LOW INCOME HOME ENERGY ASSISTANCE PROGRAM. THE APPLICATION WILL REQUIRE A SIGNATURE FROM A THIRD PARTY WHICH WOULD BE FROM ONE OF THESE PROGRAMS.
