FAMILY MUST SHOW FINANCIAL NEED. THERE IS NO SET MAXIMUM INCOME. THE DECISION IS BASED ON INDIVIDUAL FAMILY SITUATIONS I.E., HAS THE FAMILY ALREADY PAID OUT LARGE SUMS OF MONEY.
