PROVIDE IN PATIENT/OUTPATIENT SERVICE. DAY CARE, EVENING CARE, FAMILY CARE, AND CONTINUING CARE, FAMILY INTERVENTION. YOUTH EVALUATIONS, DETOX CENTER, AND RESIDENTIAL CARE. ALSO REVOLVING LOAN FUND AVAILABLE FOR PATIENTS WHO NEED TREATMENT IMMEDIATELY. APPLICANTS FOR LOAN MUST BE 19, HAVE PERMANENT ADDRESS AND HAVE ANNUAL INCOME OF AT LEAST \$15,000 WITH FINANCIAL OBLIGATIONS NOT EXCEEDING 45% OF INCOME INTEREST RATE 7%.
