SERVICES FOR INDIVIDUALS WITH SPEECH, LANGUAGE, HEARING, AND OTHER DISABILITIES ARE AVAILABLE AS A PART OF ACADEMIC PROGRAMS IN SPEECH-LANGUAGE PATHOLOGY AND AUDIOLOGY. AUDIOLOGY: INCLUDES HEARING EVALUATIONS, HEARING AID SELECTION, AND HABILITATION AND REHABILITATION FOR THE HEARING IMPAIRED. SPEECH-LANGUAGE: INCLUDES DIAGNOSTIC AND TREATMENT SERVICES FOR INDIVIDUALS WITH SPEECH, LANGUAGE, AND HEARING DISORDERS. CLIENTS RANGE IN AGE FROM INFANT TO GERIATRICS, AND MAY DISPLAY A VARIETY OF CONCERNS SUCH AS ARTICULATION, LANGUAGE, VOICE STUTTERING, HEARING LOSS, APHASIA, CLEFT PALATE, AND MOTOR-SPEECH DISORDERS. DIAGNOSTIC ASSESSMENT: AN INTERDISCIPLINARY TEAM, COMPRISED OF A SPEECH-LANGUAGE PATHOLOGIST, AUDIOLOGIST, SPEECH EDUCATOR, AND PSYCHOLOGIST PLAN AND CONDUCT INDIVIDUAL EVALUATIONS FOR SPEECH, LANGUAGE, AND EDUCATIONAL- PSYCHOLOGICAL CONCERNS. COUNSELING: IS AVAILABLE TO CLIENTS & FAMILIES WHO WANT ASSISTANCE WITH EXISTING EMOTIONAL AND/OR BEHAVIORAL DIFFICULTIES ASSOCIATED WITH THEIR OWN OR THEIR CHILDREN'S DISORDER. COUNSELING SERVICES ARE ALSO OFFERED TO INDIVIDUALS WHO ARE NOT SPEECH-LANGUAGE OR HEARING CLIENTS ON A LIMITED BASIS.
