#### **Description:**

EMERGENCY SHELTERS- SHORT TERM CRISIS SHELTER FOR CHILDREN PLACED BY CPS, POLICE OR IN CRISIS SITUATION. SUBSTANCE ABUSE INTERVENTION PROVIDED INTEGRATED SERVICES TO ADDRESS ADOLESCENT SUBSTANCE ABUSE. PREGNANCY COUNSELING FOR UNPLANNED PREGNANCY. ADOPTION AND SPECIAL NEEDS ADOPTION-ASSISTANCE, EDUCATION AND SUPPORT TEEN PARENTING PROGRAM-HOMEBASED ASSISTANCE, LIFE SKILLS TRAINING, AND PARENTING EDUCATION. THERAPEUTIC FOSTER CARE-PROFESSIONAL SUPPORT AND CONSULTATION. INDIVIDUAL AND FAMILY THERAPY-COUNSELING SERVICES FOR CHILDREN, PARENTS, AND FAMILIES FOR PARENTING PROBLEMS OR ABUSE/NEGLECT ISSUES. INTENSIVE FAMILY PRESERVATION-FOR FAMILIES AT RISK OF BEING SEPARATED DUE TO ABUSE/NEGLECT. SCHOOL & FAMILY ENRICHMENT (SAFE)-HOMEBASED SUPPORT, TRAINING, AND SKILLS TRAINING FOR FAMILIES OF AT-RISK ELEMENTARY CHILDREN IN OMAHA PUBLIC SCHOOLS. PARENTING EDUCATION-WORKSHOPS FOR PARENTS. DEVELOPMENTAL CHILD CARE-DAYTIME CHILD CARE FOR YOUNG CHILDREN KINDERGARTEN AND YOUNGER. CRISIS CENTER: 0-12 KIDS COTTAGE: 0-18
