### CHILD SAVING INSTITUTE (CSI)

#### Description:

EMERGENCY YOUTH SHELTERS, SHORT TERM CRISIS SHELTERS FOR CHILDREN PLACED BY DHHS OR POLICE. CRISIS RESIDENTIAL TREATMENT AND IN-PATIENT MENTAL HEALTH SERVICES ARE ALSO AVAILABLE FOR YOUTH AT CHILDREN'S SQUARE CAMPUS IN COUNCIL BLUFFS. CSI OFFERS MENTAL HEALTH SERVICES (MHS), INCLUDING THERAPY AND MEDICATION MANAGEMENT. CSI'S MHS ACCEPT MOST INSURANCE AND MEDICAID. CSI'S FOSTER CARE PROGRAM LICENSES FOSTER PARENTS AND PROVIDES ONGOING SUPPORT FOR FOSTER FAMILIES. INDEPENDENT LIVING SKILLS (ILS) HELPS FOSTER YOUTH TRANSITION INTO ADULTHOOD (NEBRASKA). AFTERCARE SERVICES FOR YOUTH AND YOUNG ADULTS AGING OUT OF THE FOSTER CARE SYSTEM (IOWA). TEEN AND YOUNG PARENT PROGRAM (TYPP), OFFERING PARENTAL SUPPORT AND CLASSES FOR PARENTS UNDER 25. FAMILY EMPOWERMENT PROGRAM (FEP) OFFER FREE SUPPORT GROUPS, PERSONALIZED CASE MANAGEMENT AND ACCESS TO RESOURCES FOR SURVIVORS OF DOMESTIC VIOLENCE. SCHOOL AND FAMILY ENRICHMENT (SAFE) OFFERS IN-HOME BEHAVIORAL HEALTH SUPPORT TO FAMILIES OF OMAHA PUBLIC SCHOOLS. KIDSQUAD PROVIDES IN-SCHOOL BEHAVIORAL HEALTH SUPPORT. EARLY CHILDHOOD EDUCATION (ECE) AVAILABLE AT 2 LOCATIONS FOR CHILDREN FROM INFANCY THROUGH 6 YRS OLD, PROVIDING HIGH-QUALITY EDUCATION AND CARE.
