### Description:

PROGRAMS ARE AVAILABLE IN SEPARATE FACILITIES: \*ASSISTED-LIVING FACILITIES-24 HR AWAKE STAFF, HOUSEKEEPING, MEALS, SUPERVISION OF ROUTINE ORAL MEDICATIONS FOR ACTIVE, AMBULATORY ADULTS WHO DO NOT REQUIRE NURSING HOME CARE. \*DOMICILIARY CARE-GROUP HOMES OF 18 OR LESS WHERE A HOUSEKEEPER CLEANS/COOKS THE MEALS, BUT RESIDENTS RUN AS THEIR OWN HOME. \*RETIREMENT CENTER-48 APARTMENTS FOR SENIOR CITIZENS LICENSED AS A DOMICILIARY WHERE MEALS AND HOUSEKEEPING ARE PROVIDED FOR PEOPLE 55 & OVER. \*ADULT DAY CENTERS-FOUR CENTERS FOR VARIOUS AGES/INTERESTS APARTMENTS INCLUDES MEAL/UTILITIES: MEDICAID WAIVER FOR THOSE NEEDING MORE PERSONAL ASSISTANCE AND MEDICATION SUPERVISION

AMBULATORY ADULTS NEEDING SOME ASSISTED LIVING SERVICES, BUT NOT NURSING HOME CARE. ELIGIBILITY VARIES FOR EACH PROGRAM.
