# **Eligibility:**

HOME OWNERSHIP LOANS-MAY BE USED TO BUY, BUILD, IMPROVE, REPAIR, OR REHABILITATE RURAL HOMES AND RELATED FACILITIES AND TO PROVIDE ADEQUTAE WATER AND WASTE DISPOSAL SYSTEM. HOME IMPROVEMENT LOANS-REMOVE HEALTH HAZARDS BY REPAIRING ROOFS, INSTALLING SCREENS, WINDOWS OR INSULATION, BRING THE HOME UP TO MINIMUM STANDARDS AND MAKING CHANGES SUCH AS ADDING A ROOM, REMODELING A KITCHEN.
