RENTING OUT OF FACILITY ROPES COURSE SCHOLARSHIPS AVAILABLE TO RESIDENTS OF THE STATE OF NEBRASKA WITH A DISABILITY WHO WOULD NOT HAVE THE OPPORTUNITY WITHOUT HELP.

##### **Eligibility:**

MUST HAVE A DISABILITY; BE AT LEAST 6 YEARS OF AGE. CAMPER'S ABILITIES MUST BE SUCH THAT A STAFF RATIO OF ONE STAFF TO TWO CAMPERS WILL ADEQUATELY MEET THEIR NEEDS.
