##### **Description:**

INDIVIDUAL/FAMILY SUPPORT SERVICES PROGRAM-PROVIDES SUPPORT TO INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES AND THEIR FAMILIES THROUGH EDUCATION, INFORMATION, ADVOCACY, FAMILY NETWORKING AND SUPPORT PROGRAMS. SIBSHOP PROVIDES SUPPORT FOR SIBLINGS (AGES 8-13) CONSUMER ADVOCACY PROVIDES INDIVIDUALIZED ASSISTANCE. CORPORATE ADVOCACY INCLUDES PUBLIC EDUCATION & INFORMATION, AND MONITORING LEGISLATIVE ACTIVITIES. ARC VACATION PROGRAM COORDINATES TRIPS FOR PEOPLE WITH DEVELOPMENTAL DISABILITIES. VACATIONERS PAY FOR THE TRIP OF THEIR CHOICE, WITH TRAINED ESCORTS PROVIDING ASSISTANCE AT A 1:3 RATIO. FUTURE PLANNING ASSISTS FAMILIES WITH PRESENT AND FUTURE NEEDS OF THEIR FAMILY MEMBER. RESPITE LISTINGS, ACCESSIBILITY INFORMATION. SPONSOR FOR PEOPLE FIRST. SUPPORT GROUPS, I & R. ANSWERING MACHINE AVAILABLE DURING NON-WORKING HOURS.

##### **Eligibility:**

ANY PERSON WITH INTELLECTUAL DISABILITIES, OR THEIR PARENTS OR FAMILY MEMBERS ARE ELIGIBLE FOR PARTICIPATION IN ARC OF LINCOLN PROGRAMS. INDIVIDUALS WITH OTHER ASSOCIATED DEVELOPMENTAL DISABILITIES ARE ALSO SERVED BY OUR PROGRAMS. INTERESTED COMMUNITY CITIZENS, AGENCIES, ETC., MAY REQUEST INFORMATION AND CONTACTS/ REFERRALS.
