### LAWYER REFERRAL SERVICES

#### **Description:**

THE OMAHA BAR ASSOCIATION LAWYER REFERRAL SERVICES IS DESIGNED TO ASSIST PEOPLE IN FINDING AN ATTORNEY WHO HAS EXPERIENCE WITH THEIR TYPE OF LEGAL PROBLEM. A PERSON NEEDING LEGAL ASSISTANCE CALLS THE OFFICE WHERE THE NATURE OF HIS OR HER LEGAL PROBLEM IS DETERMINED BY AN INTAKE ADMINISTRATOR. THE CLIENT IS THEN REFERRED TO A LAWYER FOR AN IN OFFICE THIRTY MINUTE CONSULTATION, OR TO AN APPROPRIATE AGENCY. THE ATTORNEY THEY ARE REFERRED TO MAY CHARGE A MAXIMUM INITIAL CONSULTATION FEE OF \$40.00 FOR THE FIRST THIRTY MINUTES EXCEPT THAT INITIAL CONSULTATIONS FOR WORKMEN'S COMPENSATION, PERSONAL INJURY, AND SOCIAL SECURITY ARE FREE OF CHARGE, IF FURTHER SERVICES ARE REQUIRED ADDITIONAL FEE ARRANGEMENTS ARE MADE BETWEEN YOU AND THE ATTORNEY AT REGULAR RATES. THERE IS NO CHARGE FOR THE REFERRAL. ALSO HELPS TO SPONSOR A MEDIATION REFERRAL SERVICE. \$40 CONSULTATION
