### VOLUNTEER LAWYERS PROJECT

#### **Description:**

THE VOLUNTEER LAWYERS PROJECT IS A REFERRAL NETWORK TO PROVIDE ACCESS TO THE LEGAL SYSTEM REGARDLESS OF ABILITY TO PAY. THERE ARE NOW ONLY 5 SELF HELP CENTERS LOCATED ACROSS THE STATE TO ASSIST WITH INTAKE INFORMATION. NO PHONE CALLS ONLY WALK INS ARE ACCEPTED. PREFER INDIVIDUALS START BY CALLING THE LEGAL AID OFFICE, BUT CAN USE WALK IN OFFICE IF NEED. THE AVAILABLE SELF HELP CENTERS ARE LOCATED IN THE COURTHOUSE OF:

BUFFALO COUNTY-FIRST FRIDAY OF MONTH 10-2

DOUGLAS COUNTY-MON, WED, FRI 10-2

HALL COUNTY-FRIDAYS 10-2

LANCASTER COUNTY-MONDAY 10-2 AND THURS 9-1

MADISON COUNTY-THIRD FRIDAY OF MONTH 10-2

THE PROGRAM SEEKS TO MATCH PEOPLE WHO HAVE CIVIL LEGAL PROBLEMS WITH ATTORNEYS WHO ARE WILLING TO PROVIDE ASSISTANCE ON A PRO BONO/REDUCED FEE BASIS. THE PROGRAM PROVIDES INFORMATION AND REFERRALS PERTAINING TO CIVIL LEGAL PROBLEMS. PEOPLE NEEDING TRANSLATORS MUST PROVIDE THEIR OWN.

#### **Eligibility:**

CIVIL MATTER-LOW INCOME FOR PRO BONO ASSISTANCE-INDIVIDUAL MUST HAVE AN INCOME OF NO MORE THAN 125% OF FEDERAL POVERTY LEVEL GUIDELINES. FOR REDUCED FEE ASSISTANCE, ONE'S INCOME MUST BE WITHIN 150% OF THOSE GUIDELINES. INTAKE INTERVIEW IS DONE BY PHONE.
