THE CAMPING AND RECREATION PROGRAM ALSO PROVIDES RESPITE WEEKENDS FOR CHILDREN AND ADULTS WITH DISABILITIES. INFORMATION AND REFERRAL PROGRAM. PROVIDES STATE WIDE AGRABILITY RURAL REHABILITATION PROGRAM THAT SERVES FARM AND RANCH FAMILIES TOUCHED WITH A DISABILITY, IT PROTECT NEBRASKAN'S OUALITY OF LIFE AND PRESERVES THEIR LIVELYHOOD. BY PROVIDING PRACTICAL GUIDANCE AND TECHNICAL ASSISTANCE, MODIFY FARM EQUIPMENT AND IDENTIFY FUNDING SOURCES.
