Description:

COORDINATES FREE AIR FLIGHTS FOR PEOPLE IN NEED OF LIFE-SUSTAINING TREATMENT AT A MEDICAL FACILITY FAR FROM HOME & CAN'T AFFORD COST OF TRAVEL. ALSO TRANSPORTS TIME-CRITICAL MEDICAL CARGO SUCH AS WHOLE BLOOD, MOTHER'S MILK, HUMAN ORGANS, AND TISSUE SAMPLES.

Eligibility:

PATIENT MUST BE AMBULATORY, AS PILOTS AND AIRCRAFT DO NOT QUALIFY AS PROFESSIONAL AID-AMBULANCES UNDER FEDERAL AVIATION REGULATIONS. REQUIRES DOCTOR'S STATEMENT THAT PATIENT IS ABLE TO FLY. MUST SHOW FINANCIAL NEED. MUST BE MOBILE AND ABLE TO ENTER A SMALL AIRCRAFT.
