Eligibility:

MUST BE A VETERAN WITH OTHER THAN A DISHONORABLE DISCHARGE AND SEVERELY VISUALLY IMPAIRED, ALSO MUST BE ENROLLED WITH, AND RECEIVING CARE THRU THE VA.
