#### **Eligibility:**

APPLICATION MUST BE CERTIFIED BY COMPETENT AUTHORITY, INCLUDING MEDICAL AND REHABILITATION PROFESSIONALS, SOCIAL WORKERS, COUNSELORS, OR LIBRARIANS. IN CASES OF READING DISABILITY, APPLICATIONS MUST BE CERTIFIED BY MEDICAL DOCTORS OR DOCTORS OF OSTEOPATHY.
