THOSE SEEN RECEIVE SAME DAY RECOMMENDATIONS AND PLANS FOR A COMPREHENSIVE MANAGEMENT PROGRAM TO MONITOR AND ADDRESS INJURY-RELATED THINKING, EMOTIONAL AND PAIN RELATED ISSUES, AND SPECIAL NEEDS SUCH AS SUPPORT TO RETURN TO WORK. COMPREHENSIVE MEDICAL REHABILITATION HOSPITAL INCLUDING VISION, PHYSICAL , OCCUPATIONAL, AQUATIC, SPEECH RESPIRATORY AND RECREATIONAL THERAPY. NEUROPSYCHOLOGY, SOCIAL WORK, PASTORAL CARE, COUNSELING AND FAMILY SUPPORT GROUPS, INDEPENDENT LIVING EVALUATION AND VOCATIONAL REHABILITATION.
