THOSE SEEN RECEIVE SAME DAY RECOMMENDATIONS AND PLANS FOR A COMPREHENSIVE MANAGEMENT PROGRAM TO MONITOR AND ADDRESS INJURY-RELATED THINKING, EMOTIONAL AND PAIN RELATED ISSUES, AND SPECIAL NEEDS SUCH AS SUPPORT TO RETURN TO WORK. COMPREHENSIVE MEDICAL REHABILITATION HOSPITAL INCLUDING VISION, PHYSICAL, OCCUPATIONAL, AQUATIC, SPEECH RESPIRATORY AND RECREATIONAL THERAPY. NEUROPSYCHOLOGY, SOCIAL WORK, PASTORAL CARE, COUNSELING AND FAMILY SUPPORT GROUPS, INDEPENDENT LIVING EVALUATION AND VOCATIONAL REHABILITATION.
