SERVICES INCLUDE: RESIDENTIAL (SMALL GROUP HOME AND SUPERVISED APARTMENT/HOME); DAY SERVICES (HABILITATION, ASSISTED VOCATIONAL, SUPPORTED VOCATIONAL); RETIREMENT; RESPITE AND TRANSPORTATION. CHILDREN ARE SERVED THROUGH CONTRACTUAL AGREEMENT WITH SCHOOL DISTRICTS FOR CHILDREN WHO NEED 12 MONTH SERVICES. SERVICES ARE BASED ON EACH PERSONS INDIVIDUAL PLAN.
