NO OFFICE PHONE. CALL SERVICE COORDINATOR DIRECTLY. ELIGIBILITY DETERMINATION FOR SPECIALIZED SERVICES; AUTHORIZING SERVICE DELIVERY FOR ELIGIBLE PERSONS; ENSURING THAT SERVICES ARE AVAILABLE, ACCESSIBLE AND COORDINATED; ASSURING THAT A TEAM PROCESS, INCLUDING THE INDIVIDUAL AND THE FAMILY, IS USED TO ASSESS AND DEVELOP AN INDIVIDUAL PROGRAM PLAN FOR SERVICES; PROVIDING INFORMATION AND REFERRAL SERVICES TO PERSONS WITH DEVELOPMENTAL DISABILITIES AND THEIR FAMILIES; AND COORDINATING LOCAL SERVICE NETWORKS.

DEVELOPMENTAL DISABILITY, EXCLUDING MENTAL ILLNESS AS A PRIMARY DIAGNOSIS. ELIGIBILITY IS DETERMINED BY SERVICE COORDINATORS.
